Incorporation Key Steps

- Step 1: Determine the type of structure/entity you need
- Step 2: Develop an operating agreement
- Step 3: Research and choose a name:
 - http://www.sos.wa.gov/corps/search.aspx
- Step 4: Appoint a registered agent
- Step 5: File articles of incorporation:
 - https://www.sos.wa.gov/
- Step 6: Wait 6-10 business days for your certificate of formation which will include your UBI

Licensing Key Steps

You've received your UBI from the Secretary of State or are registering a sole proprietorship. Your next steps include:

 Step 1: Apply for your FEIN – potential exceptions: single member LLC's and sole proprietorships with no employees:

Common Mistakes

- Neglecting industry specific endorsements
- Improper selection: Service or retail
- Improper selection: Industry/business model
- Choosing the wrong trade/DBA name
- Choosing the wrong company/corporation name
- Not electing to defer the initial annual report
- Choosing the wrong entity/structure type
- Listing insufficient communication channels
- Failing to seek advice
